
I wish you enjoyable private time in this nice month of April but also – naturally – success in your business.

#### **ECCK-WIPO Collaboration**

The ECCK and the World Intellectual Property Organization Arbitration and Mediation Center (WIPO Center) recently agreed to collaborate towards the efficient dispute resolution and protection of intellectual property (IP) rights. In particular, this cooperation entails, next to the provision of information on alternative dispute resolution (ADR) mechanisms to ECCK members, a substantial discount on the services of the WIPO Center for ECCK members.

## **WIPO Arbitration and Mediation Center**

The WIPO Center is part of the World Intellectual Property Organization (WIPO), a specialized agency of the United Nations for IP, with 188 member states, including the Republic of Korea. Operating on a neutral, international, and nonprofit basis, the WIPO Center offers time- and cost-effective ADR mechanisms such as mediation, arbitration, expedited arbitration and expert determination, which are widely recognized as particularly suitable for cross-border IP and technology-related disputes, as well as domain name dispute resolution procedures. With the establishment of its office in Singapore in 2010, the WIPO Center has strengthened its activities in Singapore and the Asia-Pacific region.

The WIPO Center is equipped with procedural rules and model clauses in different languages including Korean, a database of over 1,500 qualified neutrals in various IP fields across the world and other support tools. Moreover, the WIPO Center has administered some 400 IP arbitration, mediation, and expert determination cases in the recent years, in addition to more than 30,000 domain name cases.

#### Cooperation

Efficient dispute avoidance and resolution practices play an important role in encouraging continuity and achieving success in business. Against this background, the ECCK and the WIPO Center have agreed to join forces in offering the WIPO ADR clauses and case administration services to ECCK members. In doing so, the WIPO Center will offer a 25% reduction on its fees under the WIPO Arbitration, Mediation and Expert Determination Rules in cases involving an ECCK member. In addition to such, the WIPO Center will make itself available to offer procedural dispute resolution guidance as well as advice on choosing or adjusting dispute resolution clauses to ECCK members.

Finally, the WIPO Center and the ECCK will jointly organize seminars and trainings on dispute resolution, in order to facilitate a shared understanding of the issues that can give rise to IP and technology disputes and address various options to resolve them. The first event in this regard will take place on May 27, 2015 in Seoul and will be communicated shortly.

## **Executive Briefing Data Protection**

On Tuesday, April 7, the ECCK organized an Executive Briefing session on data protection. The topic has been of keen interest to corporations and the public, as major Korean companies have suffered a series of information leakage incidents in recent years.



In the session, about 20 executives and legal experts gathered to learn and discuss about data protection, especially regarding personal information management. Joon Yong Park from Bae, Kim&Lee, went over definitions, scope, and cycles of information management, based on Korea's Personal Information Protection Act (PIPA). Throughout the cycles, prior notification and consent to collection, use, and storage of sensitive information are the most important requirement to avoid legal disputes, according to Park.

After the informative presentation, participants continued to discuss potential information management issues over dinner.

#### The ECCK Chemical Committee

The ECCK Chemical Committee held its working level meeting on April 8 at Seoul Square. Experts from member companies discussed current issues and fixes for K-REACH.

The Act on Registration, Evaluation, of Chemicals (K-REACH) has been the most important regulatory issue in the past few

years, and the law took effect from 2015. As comprehensive as the regulation is, detailed issues are emerging for clarification and fine-tuning. Ministry of Environment and Ministry of Trade, Industry, and Energy have started dialogues with industries to further coordinate issues. The Committee also reviewed notable issues in the process and agreed to continue speaking for European chemical companies.

## **Taxation Seminar**

ECCK hosted a taxation seminar on April 9 at Hotel Lotte.

Jae-Cheol Kim, Tax Partner, and Sang-Min Ahn, Head of Transfer Pricing Services, from



E&Y presented an expert presentation updating on the topic of tax amendments and tax reforms from 2014. After the presentation, a Q&A session was held to clarify any further concerns and inquiries.



## The ECCK Attends WWF's Urban Solutions Workshop

The ECCK is in the process of establishing a Smart Cities Working Group. In order to gain insightful information from experts and better serve our members, the Chamber attended the event hosted by WWF.

On April 13, the ECCK attended WWF's workshop on "Unlocking the Power of Cities to Address the Global Climate" at Seoul City Hall. Mayor Park Won-soon of Seoul Metropolitan Government delivered introductory remarks, and leaders in urban sustainability from all over the world gave insightful presentations. The workshop concluded with an interactive panel discussion between the participants and the key speakers.

WWF has taken active actions toward the creation of sustainable cities all over the world. In 1800, only 3% of the world population resided

in cities. Currently, more than half of humanity lives in cities. Fast-forward to 2050, UN predicts that 70% of the human race will be living in cities. Therefore, it is hardly surprising to find out that extraordinary steps must be taken to conquer these extraordinary challenges facing the cities.



#### **CFO Forum**

17 CFOs from prominent companies attended the ECCK CFO Forum with presentations by Keum Ho Lee and Ilk Hwan Cho from Kim & Chang on April 16.

The forum discussed the topic of "Foreign Exchange Regulations in Korea." There has been many changes made to the Foreign Exchange Transaction System since the 1960s, but the three fundamental laws in place now are Foreign Exchange Transaction Act, Enforcement Decree, and Foreign Exchange Transaction Regulation.
