ECCK Annual General Meeting

The ECCK Annual General Meeting (AGM) was convened on Monday, February 23, 2015, at Conrad Seoul. At this year's AGM, members elected a new Board of Directors to oversee the ECCK's operations in the next two years.



Jean-Christophe Darbes, a French citizen and the President & CEO of BNP Paribas Cardif Life Insurance in Seoul, was elected to represent the ECCK as President of the Board effective immediately.

In his acceptance speech, Mr Darbes introduced the direction the ECCK would move toward under his leadership. First and foremost, he emphasized cooperation with national chambers, embassies, and European corporations to increase the "footprint" of the European industries in Korea. The new president expressed his vision of raising the presence and voice of Europe by growing together.

Mr Darbes also stated that the ECCK should focus more on assisting companies looking for investment in the Korean market. The Korean market is of growing importance for European businesses, thus these incoming businesses need to be supported by an established organization.

Finally, the new president underscored the importance of consolidating data and information to support individual European companies and institutions. He believed this function would be better suited for a general European organization such as the ECCK rather than national entities. Once again, he stressed cooperation with embassies and national chambers for this ambition.



In addition to the Board of Directors election, the ECCK debriefed on the Chamber's activities and financial status of 2014 and approved an official auditor for the year of 2015. Samil PwC was authorized to continue to be the ECCK's auditor.

As for the financial status, the ECCK had substantially stabilized and grown over the last fiscal year. Christoph Heider, the Secretary-General of the ECCK, went over the Chamber's activities and plans for 2015 in detail.

At the end of the AGM, Thilo Halter, the president of the Board for the past two years, was invited on stage and awarded the first honorary membership of the ECCK as a token of appreciation for his service.
