Its flexible sorting systems perform an extensive range of sorting tasks and are able to both sort and upgrade various types of metals, plastic and paper waste for material recycling. For example, today in Asia, more than 3.5 million tons of post-consumer PET bottles every year are processed by TOMRA optical sorters to different grades of recycled material. In South Korea mixed plastic packaging waste collected from more than 25 million inhabitants are sorted by TOMRA systems into different mono fractions for recycling. TOMRA is a listed-company at stock exchange in Oslo, Norway.

Mr. Park is a renowned waste expert. Ever since joining TOMRA as the first employees in Asia in 2006, he has made tremendous contribution to the development and modernization of waste and recycling industry in various countries in Asia Pacific including South Korea, Japan, China, SE Asian countries, India as well as Australia. Prior to TOMRA, Mr. Park worked at Norwegian Embassy in Seoul as Commercial Officer in charge of introducing and promoting Norwegian industries in the fields of Energy, ICT and Environment to Korean business partners and customers.
