Jae-Mook Lee is an associate professor of political science and director of the global politics institute at Hankuk University of Foreign Studies (HUFS) in Seoul.

He is active academically, and currently acts as council member of the Korean Political Science Association (KPSA) and Korean Party Studies Association (KPSA).

His field of expertise encompasses political behavior such as elections, political parties, and public opinion. He has published papers in various domestic and foreign academic journals such as the Korean Political Science Review, Korea Observer, Asian Perspective and International Journal of Communication. He appears frequently in the media to comment on Korean politics. He graduated from Yonsei University with a BA in Political Science and Diplomacy and received his Ph.D. in Political Science from the University of Iowa, USA.

Oh Young-jin has acted as president and publisher of the Korea Times since April 2020.

He joined the Korea Times in 1988 as staff reporter, and worked at various desks covering politics, business and the city both as reporter and desk editor before becoming managing editor in 2012.

He served as managing editor through 2015, before becoming a chief editorial writer, and then digital managing editor and director of content and digitization.

He graduated Sungkyunkwan University with a BA in Chemical Engineering.



Warwick Morris  
Former British Ambassador to

Warwick Morris was a professional diplomat for 39 years and served as Britain's Ambassador to South Korea from 2003-08. He also spent 3 years as Ambassador to Vietnam. As a diplomat, he served three times in South Korea, for a total of 13 years, including 18 months learning Korean at Yonsei University. Trade, investment and economic issues have been an important part of his work, and he made visits to North Korea in 1991 and 2004. He is now a senior advisor to GR Korea.

Warwick is a member of the British Association of Korean Studies and served as Executive Chairman of the British-Korean Society from 2011-17. He regularly participates in Korea-related workshops and seminars, and comments on Korea for the BBC and other broadcasters. He was Honorary President of the British-Korean Law Association and is a founder and current Chairman of the Vietnam-UK Network.
